## READ AND UNDERSTAND THE SDS BEFORE USING THIS PRODUCT. (available at caliberproductsinc.com).

**CAUTION:** The surface must be clean, dry and free from all contaminants. Especially waxes, grease, oils or any residue. If any of these are present, thoroughly clean the surface first with LACQUER THINNER. If you do not do this, Alumi-Skin may have a streaky appearance, or may not adhere.

TO CLEAN: (New Aluminum) Thoroughly clean the surface with a mild scap and water solution to remove all contaminants, let dry then apply Alumi-Skin. (Oxidized Aluminum) Clean first with Alumi-Etch to remove streaks, stains and oxidation, dry, then apply Alumi-Skin.

**TO APPLY:** We recommend using a WHITE COTTON TOWEL/DIAPER ONLY! Look for the description "FLAT FOLD, BIRDSEYE WEAVE" on the packaging. These can be found at department stores and on line. For large areas, fold the cloth into a thick smooth pad about the size of your open hand. For smaller areas, cut the cloth down to an appropriate size. SATURATE the cloth by pouring Alumi-Skin directly from the container on to cloth. NEVER pour Alumi-Skin into a pan and dip cloth. A single swipe is all that's needed to apply a coat of Alumi-Skin. On larger areas, apply Alumi-Skin in sections. Moving from left to right, make a straight horizontal swipe (up to ten feet).

**APPLICATION:** Although Alumi-Skin can be applied in any temperature from 20°F to 100°F, the cooler the temperature the better the finish.

WARNING: FLAMMABLE. VAPOR HARMFUL CAN CAUSE IRRITATION OF EYES, SKIN AND RESPIRATORY TRACT. Avoid contact with eyes and skin.
