Route Sheet Holder Installation







- Remove the lens from the route sheet holder, by prying up the front lens tab with a screwdriver until it disengages from the molded tab on the route sheet holder.
- Remove the supplied clamp and turn the clamp screw counter clockwise to disengage the clamp threads and separate the clamp ends.
- Insert the supplied clamp through the slots in the bottom of the route sheet holder as shown in (Figure 1)
- Place the route sheet holder on the left side of the handlebar in a convenient position with the clamp around the handlebar. (Figure 2) Push the clamp ends together and turn the clamp screw clockwise to engage the clamp threads.
- Use an 8mm socket or t-handle to tighten the clamp around the handlebar. (Figure 3)
- 6 Load your route sheet.
- Replace the lens on the route sheet holder by pushing down on the front and back sides of the lens until the lens tabs snap over the molded tabs on the route sheet holder.

Note: It is also possible to mount the route sheet holder to a cross bar by using the supplied rubber hose. First cut the rubber hose lengthways with a knife or side cutters, then put the rubber hose over the cross bar, and then clamp the route sheet holder over the rubber hose.
