construction: two semicircular pieces of fuel color declared "GF NYLON 15%" marked "LEATT DBX" of white color; **quick-release system** in the event of accidents by means of a red metal screw on the left side declared "Aluminium 6061 T6"; on the right side instead, quick-release system in the event of accidents by means of a red button placed under the neck brace, marking "OPEN" placed on the frame;

padding: declared composition: black EVA foam;

front (in contact with the chest): declared composition: white "GF NYLON 15%" marked "FIVE-FIVE" in red, matched with declared black EVA foam;

The front part of the neck brace can be adjusted by means of a red lever marked "LIFT HERE";

back side (in contact with the back): declared composition: white "GF NYLON 15%", marked "FIVE-FIVE" in red, matched with declared black EVA foam.
