


FITTING INSTRUCTIONS FOR FP0127BK FORK PROTECTORS SUZUKI DRZ400 SM 2006-9






THIS KIT CONTAINS THE ITEMS PICTURED AND LABELLED BELOW. DO NOT PROCEED UNTIL YOU ARE SURE ALL PARTS ARE PRESENT.

Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with a plastic tube separating components on the spindle bar (this tube should be discarded).

THE PARTS SHOWN MAY BE REPRESENTATIVE ONLY (FOR CLARITY OF INSTRUCTIONS ONLY)





TOOLS REQUIRED

Socket set to include 2x 13mm sockets

FITTING INSTRUCTIONS

- Fit one nut and washer on spindle-bar (SB015) (the end with shorter spigot), engage the nut so the plastic insert of nut is fully engaged.
- Feed spindle-bar with nut and washer through either crash protector (B0442M) and through the metal spacer (S0553 this is the larger stepped spacer), as shown in the above picture.
- Place this assembly through the front wheel spindle from the right hand side, ensuring the smaller diameter of the spacer goes in first.
- Place the remaining spacer (S0552 the smaller stepped spacer) and crash protector over the exposed end of the spindle bar on the left hand side of the bike.
- Fit washer and nut from the kit onto thread and tighten until both nuts are engaged in nylon and equal amounts protrude from either side (please ensure the logo is located at the top and bottom of the crash protector). Do not overtighten the nyloc nuts will hold it tight.
